We project that carbon emissions will decrease over the next five years to **36936** tCO₂e by 20**27**. This is a reduction of **30**%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2020 baseline. The carbon emission reduction achieved by these schemes equate to **16,781** tCO₂e, a **24**%ge reduction against the 20**20** baseline and the measures will be in effect when performing the contract.

In the future we hope to implement further measures such as:

Reduction in Office Space, removing an additional refrigerator and generating less electricity consumption.
